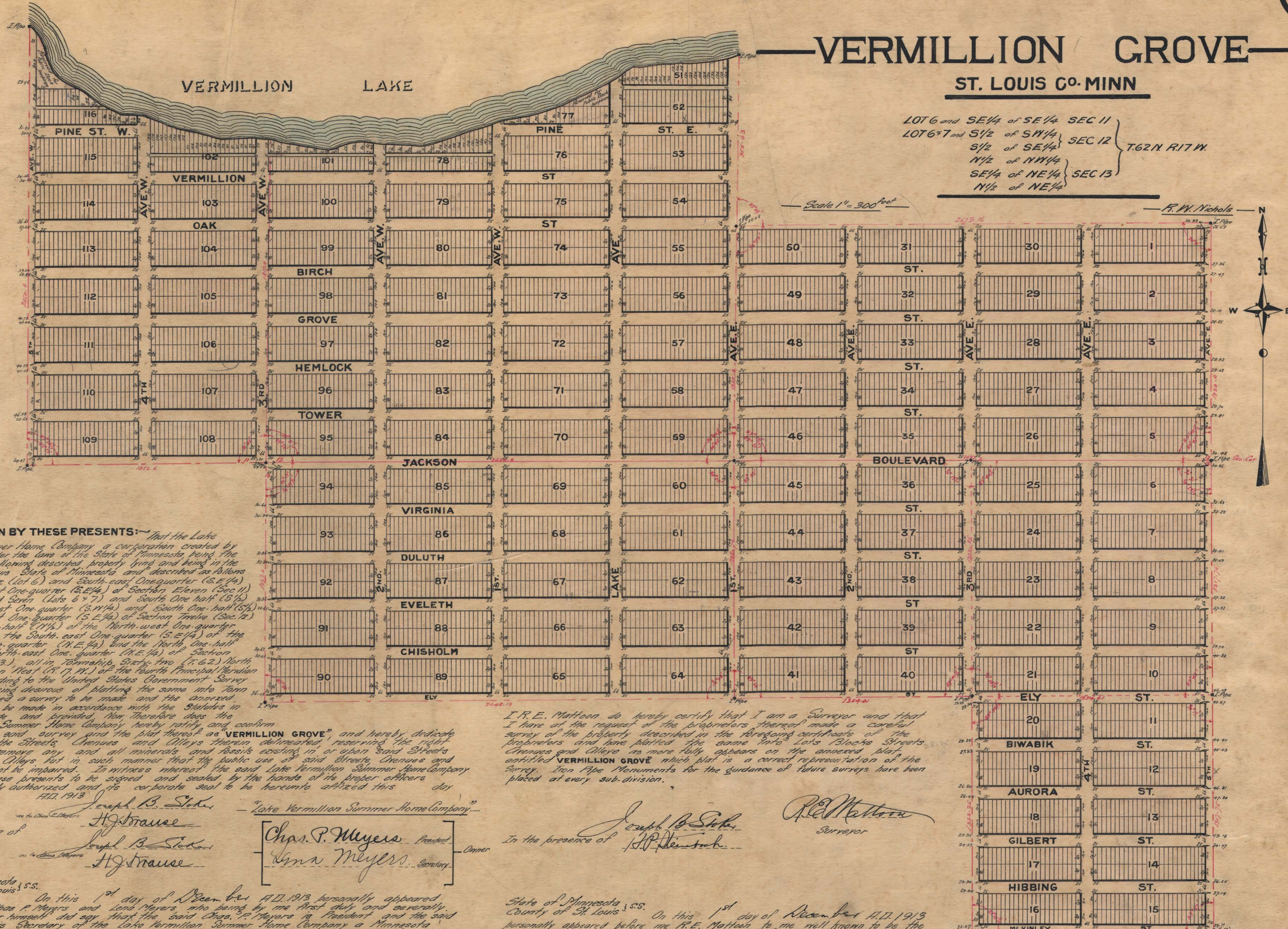


VERMILLION GROVE

KNOW ALL MEN BY THESE PRESENTS:

That the Lake Vermillion Summer Home Company a corporation created by and existing under the laws of the State of Minnesota being the owner of the following described property lying and being in the County of St. Louis State of Minnesota and described as follows to wit: - Lot Six (Lot 6) and South-east One-quarter (S.E. 1/4) of the South-east One-quarter (S.E. 1/4) of Section Eleven (Sec. 11) and Lots Six and Seven (Lots 6 & 7) and South One-half (S 1/2) of the South-east One-quarter (S.E. 1/4) of Section Twelve (Sec. 12) and North One-half (N 1/2) of the North-west One-quarter (N.W. 1/4) and the South-east One-quarter (S.E. 1/4) of the North-east One-quarter (N.E. 1/4) and the North One-half (N 1/2) of the North-east One-quarter (N.E. 1/4) of Section Thirteen (Sec. 13), all in Township Sixty-two (T. 62) North Range Seventeen West (R. 17 W.) of the Fourth Principal Meridian (4th P.M.) according to the United States Government Survey thereof and being desirous of platting the same into Town Lots, have caused a survey to be made and the annexed plat thereof to be made in accordance with the Statutes in such cases made and provided.
